Personally came P M Stoddard who makes oath before a Magistrate of this Court that Justin Ross Harris (hereinafter called the accused) AKA: did, on 6/18/2014 at 04:23 PM at 2955 Akers Mill RD, Atlanta in the County of Cobb, Georgia, commit the offense of CRUELTY TO CHILD-1ST DEGREE, felony(F) violating O.C.G.A, Section 16-5-70(a), for that said accused being a parent, guardian, or other person supervising the welfare of or having immediate charge of custody of a child under the age of 18 commits the offense of cruelty to children in the first degree when such person willfully deprives the child of necessary sustenance to the extent that the child's health or well-being is jeopardized, to wit: said accused did leave a 22 month old juvenile male unattended and strapped into a child car seat in a parked vehicle for approximately 7 hours during daytime hours after which the child was found deceased. The outside temperature at 1716 hrs that day was 88 degrees per Dobbins Air Force Base Weather Service; on 6/18/2014 at 04:23 PM commit the offense of MURDERFELONY(F) violating O.C.G.A, Section 16-5-1, for that said accused did commit the offense of HOMICIDE-MURDER DURING COMMISSION FELONY (F) violating O.C.G.A., section 16-5-1(c), for that said accused did commit the offense of murder when, in the commission of a felony, said accused did cause the death of another human being irrespective of malice, to wit: said accused did commit the felony offense of CRUELTY TO CHILD FIRST DEGREE, 16-5-70(b), by leaving a 22 month old male juvenile unattended in a parked vehicle while strapped into a car seat for approximately 7 hours during the daytime which resulted in the death of the juvenile. The outside temperature at 1716 hrs that day was 88 degrees per Dobbins Air Force Base Weather Service;  
and affiant makes this affidavit that a warrant may issue for the arrest of the accused.
