



Official Rules

**\$1,000 Workday Kick-Off
Fall 2017**

1. WHO MAY PLAY

No purchase is necessary to enter or win.

Must be at least 18 years of age or over. Legal photo ID required.

Contest open only to legal Florida residents except employees of Cox Enterprises, Inc. /Cox Media Group and its partially and fully owned subsidiaries and participating sponsor(s) and the immediate families of those employees. The term "immediate family members" includes spouses, parents, grandparents, siblings, children, and grandchildren.

No other local radio company employees may play. A person may only win once during this contest and only one winner per household.

No purchase necessary to enter or win. A purchase will not improve your chances of winning. All federal, local and municipal laws and regulations apply. Void where prohibited.

2. CONDITIONS OF WINNING

Winners must sign promotional release form as condition of receiving prize. Winner is responsible for all taxes. Prizes must be claimed in person, by the actual winner, at the 105.5 The Dove (WDUV) business office within 30 business days or be forfeited. A person may not play the "\$1,000 Workday Kick-Off" contest if they have won a contest with WDUV in the previous 30 days.

\$1,000 Workday Kick-Off Contest Winners are not eligible to win any contest on WDUV for 30 days. Additionally, all \$1,000 Workday Kick-Off prize winners may only win once during this contest; one winner per household. Substitution prizes are not allowed.

105.5 The Dove (WDUV) will not be responsible for loss of service to the call-in line or for a contestant's failure to reach the call-in line due to malfunction of any network or system, congestion, overload, busy signals, or any other factor that may prevent an individual from completing his/her phone call. In the event of interruption of power or telephone service to WDUV during the \$1,000 Workday Kick-Off call in period and prior to accepting the winning caller, the call-in period affected by the interruption may or may not be replayed at the resumption of service, at WDUV's sole discretion. The use of automatic telephone dialing equipment or other software or computer assisted dialing equipment is prohibited and will result in disqualification. In the event that there is a technical problem with the telephones or equipment beyond WDUV's control during the contest, the contest will cease at that moment and all parties on the line will be disconnected. WDUV reserves the right to suspend the contest at any time due to weather emergencies, acts of terrorism or war, technical difficulties, or any other circumstances beyond the control of WDUV. In the event that any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.

5. SPONSOR

When this plays, the 10th caller (each time) will each win \$1000 cash. Listeners will need to call the designated studio line at (888) 723-9388. The tenth caller when the Cue to Call plays at approximately 8am will be chosen as the winner of \$1000 cash. Eligibility must be confirmed, for winner to actually receive the prize. WDUV is not responsible for the winner being unable to claim their prize. Prizes may not be changed, exchanged, swapped on the part of the winner. WDUV reserves the right to alter the contest execution at any time. WDUV will not be responsible for any additional costs incurred by winner and/or guest.
