The undersigned Affiant, who after being duly sworn by me, on oath, makes the following statement: I have good reason to believe and do believe that **Montrel Meander (B/M 9-20-94)** on or about the **21st** day of **June, 2014**, did commit the offense of **Sexual Assault (2nd Degree Felony)**. My belief of the foregoing statement is based upon personal knowledge and information provided to me by Jane Doe (pseudonym), UT Austin Police Officers Miller # 1794, Villarreal #1744, Allen #1743 and Lieutenant Bonnet #1269, all of whom I believe to be credible persons living and working in Austin, Texas.

On June 21st, 2014 at around 3:43am, University of Texas Police Officers were dispatched to a report of sexual assault at the San Jacinto Hall Dormitory (SJH), 301 E. 21st Street, University of Texas at Austin campus, Austin, Travis County, Texas.

When the officers arrived they found the victim tucked underneath the SJH entry service desk crying. She was barefoot and her hair disheveled. The victim told the officer she had gone to 6th Street the night of June 20th with her girlfriends and had run into Montrel Meander, who she has known as a friend for over a year. In the early morning of June 21st, the victim accepted a ride back to San Jacinto Hall from Montrel Meander. Once at SJH, the victim separated herself from the group of friends she was with in the lobby and agreed to go up to Meander's dorm room, #4209. The victim asked to take a shower because she had either vomit or some other foreign material on her leg which she wished to wash off.

After having showered, she and Meander agreed to engage in consensual sex with each other. After several minutes of having sex together there was a knock at the door. Meander got up from the bed and answered the door. The victim stayed in bed naked underneath the covers while Meander answered the door. Meander opened the door and allowed the person knocking to enter. The person who entered the room was identified by the victim as Kendall Sanders, who she has known personally as a friend for over a year.

When Sanders entered the room, Meander walked into the bathroom. Sanders began taking off his clothes, which were athletic shorts. The victim told Sanders to stop and that she did not want to engage in sex with him. Sanders got in the bed anyway and forcibly penetrated her vagina with his penis. The victim told Sanders to stop, that she did not like what was happening. Sanders told the victim she would like it and that it is going to feel good. The victim had her legs crossed, trying to guard her private area during the forced entry. Sanders lifted the victim's legs up in the air while forcibly penetrating the victim's vagina with his penis. Sanders was then able to separate the victim's legs and place one of the victim's legs around his waist. From this position, Sanders continued to penetrate the victim's vagina with his penis.

While still in the bed, Sanders forcibly put his penis into the anus of the victim, which she described as being extremely painful. Sanders then picked up the victim and placed her on a black rug on the floor. Sanders got behind the victim while she was on her hands and knees and used his penis to forcibly penetrate the victim's anus. The victim tried using her leg to push Sanders away because the penetration of the victim's anus was extremely painful. The victim vocalized to Sanders that she was uncomfortable and did not want to have sex with him.

During this time Meander came back into the room. Both he and Sanders forcibly penetrated the victim by putting their penises into her vagina and mouth. The victim asked Meander why he was doing this and he did not reply, he just stared at her. The victim told us that she withdrew her consent to penetration by Meander. The victim asked to leave and Sanders said "you could leave after I am done". The victim closed her eyes and tried to mentally and emotionally remove herself from the situation. At that time she was not able to discern who was doing what to her. At some point either Sanders or Meander ejaculated in the victim's mouth.

The victim saw a flash and suspected the use of a cell phone to take a video or photo of her. The victim asked both Sanders and Meander about the photo and Sanders told her that there was not a photo. The victim then dressed and left the room crying.

Detectives with the University of Texas Police Department interviewed both Sanders and Meander at the University of Texas Police Station. While being questioned separately by Detectives Meander and Sanders began texting each other, trying to get their story straight. Detectives were able to get written consent from Meander and Sanders to look at the pictures on their phones. Detectives were able to locate at least one photo of the victim on Sanders' phone during the time of the interview.

I believe Montrel Meander was criminally responsible for the conduct of another P.C 7.01 (a) A person is criminally responsible as a party to an offense if the offense is committed by his own conduct, by the conduct of another for which he is criminally responsible, or by both. (b) Each party to an offense maybe charged with commission of the offense.

I believe that Montrel Meander committed the offense of Sexual Assault P.C 22.011(a) A person commits an offense if the person (1) intentionally or knowingly (a) cause the penetration of the anus or sexual organ of another by any means, without the person's consent. (b) Causes the penetration of the mouth or another person by the sexual organ of the actor, without that person's consent.



A person commits an offense if the person photographs or by videotape or other electronic means visually records another without the other person's consent and with intent to arouse or gratify the sexual desire of any person.
