Narrative

On 07-01-10, I was assigned this case regarding Southeast Laser and Surgery and it's owner, Sharon Chavez-Yawn who has been accused of practicing medicine without a license. This complaint originally came from Steve Wills who is a State of Georgia Medical Board investigator. Wills is the senior investigating agent for the medical board. Wills receive several complaints from clients of Southeast Laser and Surgery. The complaints ranged from receiving burns while receiving Accent and Fraxil laser treatments to scaring while having tattoos removed using lasers. The complaints stated that Sharon Chavez-Y was the individual who conducted the laser treatments. There has also been numerous complaints about the breast augmentation procedures done at Southeast Laser and Surgery. Those complaints site that Chavez-Yawn and Dr David Marshall Cheney have done breast augmentations on women with a undesired result. Dr Cheney is the doctor who is employed by Southeast laser and Surgery to perform plastic surgery procedures at the business. Numerous client have said that while Dr Cheney performs breast augmentation surgery on the clients left breast, Chavez-Yawn is performing breast augmentation on the right.. Chavez-Yawn is not licensed to perform any type of surgery. Chavez-Yawn has not medical licensing of any type.
